

S.R.O. 598(I)/2022. – In exercise of the powers conferred by sub-section (1) of section 3 of the Imports and Exports (Control) Act, 1950 (XXXIX of 1950), the Federal Government is pleased to direct that the following further amendments shall be made in the Import Policy Order, 2022, namely:-





2. The import of products listed under Sr. No. 53 to 85 of this Order shall remain prohibited regardless of their import status elsewhere in the Import Policy Order, 2022.
