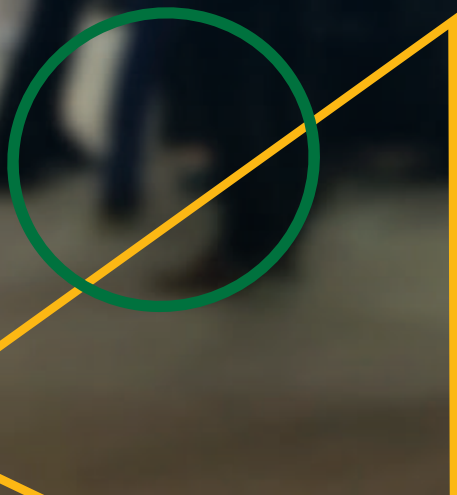

2. CANCELLATION

The Contract shall be cancelled and no refund shall be made if the applicant cancels his/her participation for any reason whatsoever, after submitting his/her application.

3. PROTECTION OF EXHIBITS

- A) The Organizer shall undertake, with the care of a competent manager, the protection and maintenance of the exhibition hall as a whole;
- B) The custody of exhibits and related material remains under the responsibility of each exhibitor;
- C) The Exhibitor is required to insure his exhibits and related materials, removal and display and also to take necessary measures to safeguard those exhibits and materials.

4. EXEMPTION CLAUSE

Should the Organizer decide to change the duration of the fair or cancel the fair due to natural calamity, or other force majeure, the Organizer shall refund the participation fee already paid by exhibitors.

5. REGULATIONS AND COMPLIANCE

- A) The Organizer may change parts of the regulations of participation in the 26th Addis Chamber International Trade Fair, but any changes will be communicated to the Exhibitors immediately,
- B) The Organizer will provide general information, subsidiary regulations and other documents covering various information needed to carry out operations of the fair,

ALLOCATION OF STANDS

- In-door space: A single stand has an area of 3x3=9sq. m., which is the minimum allocable space. Additional space can be allocated in multiples of 3(12, 15, 18,) square Meter
- Out-door space: No minimum area has been set for out door space. It will be handled in accordance with a common agreement to be concluded between the participants and the organizer in a manner that will maximize best utilization of space

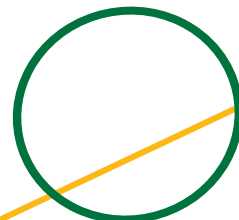
